第一條 (目的)

為鼓勵國內外優秀碩、博士生就讀,特訂定「臺北醫學大學醫學檢驗暨生物技術學系及醫學生物科技博士學位學程(以下簡稱本系所學程)研究生獎勵學金實施要點」(以下簡稱本要點)。

第二條 (申請資格)

入學本系所學程且未獲中華民國(以下簡稱我國)政府機關(構)提供之獎學金、我國政府機關(構)以外之其他機構提供之全額獎學金且為:

- 1.本校醫學檢驗暨生物技術學系本國碩士一般生。
- 2.本校醫學生物科技博士學位學程博士候選人。

第三條 (獎勵學金名額)

視當年度各項經費預算及申請人數彈性調整。(碩士班至多 16 名、博士班至多 5 名)

第四條 (經費來源)

本要點之經費來源,由以下募款經費支應:

- 1. 醫學科技學院院務發展基金。
- 2. 吉研檢驗醫學發展基金
- 3. 其他經本系所學程核可之經費。

第五條 (獎勵金額度)

- 1.本國碩士班(含學碩一貫)獎勵金額為每人每月至多新臺幣三仟元 ,每學期核發,至多受獎二學年。
- 2.資格考通過之博士候選人獎勵金額為每人每月至多新臺幣八仟元,至多受獎一學年。

第六條 (申請審查機制)

符合資格者,需於每學年初提出申請。提出申請後,經本系所學程學生輔導委員會審查通過後,始得核發。

第七條 (核放時間)

每次受獎核定以一學年為期,依第五條規定發放;自學年開始之月 份開始發放,至該學年度結束為止(應屆畢業生發放至離校當月,最 遲至七月底)。依境外研修作業要點核准出國學習研究期間,獎勵學 金發放以二個月為限。

第八條 (停發條件)

受獎生有下列情事者,本系所學程得停止發放獎勵學金或取消其受獎資格:

- (一)有休學、退學、開除學籍、轉學或轉系所等情事。
- (二) 違反校規受記過以上處分或違反本系所學程規範。
- (三)未依本校學生境外研修作業要點申請下出國,「隔月」即停發獎勵學金,直到返國就學為止;但因出國交換或其他原因經本系所學程審查同意則不在此限。
- (四)受獎者經查申請過程若有偽造或不實之情事,撤銷其受獎資格,已領取之獎勵學金應予繳回。

第九條 (特殊案例)

如有特殊情事得以專案申請,由系所學程會議另案討論。

第十條 (核決權限)

本要點經本系所學程會議、院務會議通過,送學生事務會議審查通 過後公布施行;修正時亦同。

Incentive Scholarship Implementation Guidelines for Graduate Student of School of Medical Laboratory Science and Biotechnology and Ph.D. Program in Medical Biotechnology, Taipei Medical University

Article 1 (Purpose)

In order to encourage the excellent graduated students of our country and foreign countries to apply, we hereby set forth the "Guidelines for Graduate Student Incentive Scholarship of School of Medical Laboratory Science and Biotechnology and Ph.D. Program in Medical Biotechnology (hereinafter referred to as the Department or the Program), Taipei Medical University" (hereinafter referred to as these Guidelines).

Article 2 (Applicant Qualifications)

Enrolled in the Department or the Program and does not acquire the scholarship provided by the Republic of China (hereinafter referred to as our country), the full scholarship provided by the organization other than the governmental agency (institute) of our country, and is:

- 1. Local student in the master's program of the School of Medical Laboratory Science and Biotechnology of this University.
- 2. Doctoral candidate of the Ph.D. Program in Medical Biotechnology of this University.

Article 3 (Number of People the Incentive Scholarship Granted)

The number of people granted is flexible and adjusted according to the various funds and budgets, and the number of applicants for the concerned school year (a maximum of 16 for the master's program, a maximum of 5 for the Ph.D. program).

Article 4 (Fund Source)

The funding for these Guidelines comes from the following sources:

- 1. College Affairs Development Funds of the College of Medical Science and Technology.
- 2. Ji-Yien Laboratory Medicine Development Funds.
- 3. Other funds that were approved by the Department or the Program.

Article 5 (Quota of Incentive Scholarship)

- 1. For students of master's programs in our country (including combined BA-MA), the incentive scholarship amount is a maximum of NTS 3,000 per month per person. It is approved and paid every semester, and up to two school years.
- 2. For doctoral candidates who pass the qualification exam, the incentive scholarship amount is a maximum of NTS 8,000 per month per person and up to one school year.

Article 6 (Application Review Mechanism)

The qualified applicant shall file an application at beginning of every semester. The scholarship will be paid after the application is filed and then reviewed and approved by the Student Counseling Committee of the Department or the Program.

Article 7 (Time of Payment)

The duration of the incentive scholarship is a semester and is

paid according to the provisions of Article 5 and the time of payment is from the first month of the semester to the end of the semester (new graduates will be paid in the month of graduation and not later than the end of July). During the period of approval to study aboard, according to the Outlines for Overseas Training, the payment of the incentive scholarship is limited to two months.

Article 8 (Conditions of Stop Granting)

The Department or the Program may stop granting the incentive scholarship or cancel the granted qualification if any of the following situations of the granted students occur:

- (1) Student has taken a temporary leave, quit, been expelled from school, or transferred to another university or department, etc.
- (2) Student was disciplined with a demerit or more severe punishment for violating the regulations of the University, the Department or the Program.
- (3) Student has traveled abroad but has not filed an application in accordance with the Regulations Pertaining to Overseas Studies or Research for the Student of this University, the payment of the incentive scholarship will be suspended from the "following month" after the departure, until the student returns and resumes studying at the University. However, a student who is included in foreign exchange study or has to travel abroad for other reasons reviewed and approved by the Department or the Program is not subject to this provision.
- (4) Scholarship recipients will be disqualified from receiving scholarships if there is any counterfeiting or untrue

information during the application process, and the student shall pay back the incentive scholarship received.

Article 9 (Special Case)

If there is any special situation that can be applied as a special project, and discussed by the meeting of the Department or the Program.

Article 10 (Approval Authority)

These Guidelines shall be implemented on the date of promulgation upon approval by the Department or the Program Meeting, the Collage Affairs Meeting and forwarded to the Student Affairs Meeting for review and approval. Any amendments shall be processed accordingly.
